## **ESASI New Corporate Member**

ESASI welcomes the **GPIA** Safety Investigation Authority of Portugal – GPIAAF as its most recent affiliated corporate member. The Office for the Prevention and Investigation of Accidents in Civil Aviation and Rail (Gabinete de Prevenção e Investição de Acidentes com Aeronaves e de Acidentes Ferroviários in Portuguese) is an independent multimodal authority created in April 2017, with the merger of the existing civil aviation and rail safety investigation authorities. GPIAAF is headquartered in Lisbon with a satellite hangar at Viseu aerodrome which is used for the storage of civil aviation wreckage. In the civil aviation domain, GPIAAF's mission is to fulfil the provisions of ICAO's Annex 13, EU

Regulation No 996/2010 and Portuguese Decree-Law 318/99 through the investigation of civil aviation accidents and serious incidents aimed at prevention of future accidents, and engage domestic and international stakeholders in the dissemination of lessonslearned to foster the continuous improvement of aviation safety. GPIAAF is actively involved in the ECAC group of experts in accident/incident investigation and ENCASIA's EMSS and Peer Review Working Groups.

## ESASI's 40<sup>th</sup> anniversary



Congratulations are in order as ESASI marked it's 40<sup>th</sup> anniversary in 2024. The original constituition of ESASI was established on the 11<sup>th</sup> September 1984

in the United Kingdom by ISASI

members who worked at British Airways and the UK AAIB. Members from Austria, Denmark, France, Germany, Italy, Norway, Sweden and Switzerland offered their services in creating ESASI. The constituition refers to the following four issues which justified the establishment of ESASI in 1984:

- To create a body which, "could act as the catalyst for the informal exchange of ideas, problems, attitudes, etc. [which] can be very effective in making formal exchanges much smoother and less onerous".
- 2. "The tide of change is tending to unify Europe and this is particularly evident in the aviation industry".
- 3. "[...] Large enough and growing membership in Europe to justify the development of consensus European views [...]."
- "[...] The formal identification of the European Society will lead to a clarification of the advantages and to a growth in membership."

Many of these points are of relevance still today and are an integral part of ESASI's

mission which we strive to fulfil together with our members and friends. Here's to the next 40 years!

## ISASI 2024 seminar in Lisbon

The highlight of 2024 was the ISASI seminar which ESASI organised in Lisbon, from the 1<sup>st</sup> to the 3<sup>rd</sup> October 2024. This was preceded by tutorials on the 30<sup>th</sup> September



on Human Factors/Mental Health and Fire Investigation. The MASI group also held its meeting before the main seminar. The theme for the main seminar was, 'Safely Navigating Uncharted Waters'; a reflection on the innovation and pioneering spirit of the Navigators of old, who spearheaded the exploration of new frontiers. The seminar was attended by over 300 delegates from across the globe, from industry and government, addressing emerging issues that are influencing aviation safety and the challenges faced by investigators with the expansion of commercial space operations, increasing use of unmanned aerial vehicles, introduction of urban mobility, and alternative propulsion systems - often with organisations new to aerospace. ISASI 2024 was the culmination of two years of effort by the ESASI Committee in making preparations for what became a memorable ISASI seminar, with an exciting technical programme alongside social opportunities for networking. An overview of the programme and some of the key discussion points will be distributed separately.

## Thank you, Brian McDermid



The Committee and Trustees of ESASI would like to express their heartfelt thanks to Brian McDermid. Brian has recently retired from the UK Air Accidents Investigation Branch (AAIB) and is therefore also standing down from the Committee of ESASI.

Brian joined the AAIB in 2004, direct from his career as an engineering officer in the Royal Air Force. During his 20 years at the AAIB he participated in 417 investigations, 192 as Inspector in Charge. He was involved in a number of major investigations, most prominently his work on fuel icing following the accident to a British Airways B777, G-YMMM, at Heathrow in January 2008. Brian was also seconded for several months to assist with the establishment of the UK's Healthcare Safety Investigation Branch.

Until Brexit, Brian took an active role in the work of the European Network of Civil Aviation Safety Investigation Authorities (ENCASIA) where for several years he was the secretariat and Chair of the Peer Review and EMSS working groups. In particular, the ENCASIA Mutual Support System (EMSS) has paved the way for regional cooperation to manage major investigations in Europe. Brian was instrumental in setting up a roadmap to gradually add tools to make the network more operational. He also had a key role in the ENCASIA team that organised and delivered trainings over a number of years on investigation management, which included five major accident desktop exercises.

Since 2009 Brian had been increasingly involved in ESASI and was Chair of the Technical Committee for the successful ISASI Seminar in Augsburg (2015) and was on the organising committee for Reykjavik (2016). He brought huge enthusiasm and experience into the ESASI leadership and lead the Technical Committee for the ESASI seminars in Madrid (2013), Milan (2014), Ljubljana (2017), Riga (2018), Derby (2019), Budapest (2022) and Bratislava (2023). The continuing ESASI 'FocusOn...' technical webinars have also been a product of Brian's fertile creativity and bounding energy. Finally, he led the Technical Committee for the recent successful ISASI seminar in Lisbon, for which we at ESASI thank him and wish him the best in his future 'postaviation' projects.

#### FocusOn... Safety Management Systems

ESASI will hold its next FocusOn... webinar on the topic of Safety Management Systems (SMS) on the 5th March, 2025. While the requirement for commercial operators to have an SMS in place has been in force for many years, other aviation domains such as air navigation, maintenance, design and production organisations are more recently required to have implemented a formal SMS. FocusOn... Safety Management Systems will address the issue from the perspective of organisations with a mature SMS and others who are more recent on their path towards a formal SMS. While attendance of the webinar is free, we request delegates kindly to register beforehand to receive their access details. Registration details and programme will be made available soon.

# Annual General Meeting 2024 Report 1 October 2024

#### Annual General Meeting of the European Society of Air Safety Investigators

In accordance with its Constitution, the ESASI Annual General Meeting (AGM) was held during the ESASI annual event. It took place in the Marriott Hotel in Lisbon, Portugal on 1-3 October 2024. For 2024, ESASI organized the ISASI annual seminar in Europe, which replaced the ESASI regional seminar. ISASI 2024 was preceded by the MASI (Military Air Safety Investigators) meeting and the ISASI tutorials on 30 September 2024.

### Introduction, 2023 AGM Report & Activity – Nuno Aghdassi (President)

The AGM was opened by Nuno Aghdassi, ESASI President, introducing the ESASI Committee and their roles in ESASI. The Committee was reinforced with the election of Paula Dugdale who joined early 2024.

Nuno sought approval of the 2023 AGM report, which had been sent out by Olivier Ferrante (Secretary) on 3 June 2023 and resent on 18 September 2024. There was no dissent, and the 2023 AGM report was accepted by the AGM.

Nuno then described ESASI activities since the 2023 Seminar in Bratislava:

- FocusOn... Communicating with families, 15 November 2023
- ESASI elections and re-arrangement of roles, January 2024
- Regular meeting held every 2 weeks and other activity meetings held in between
- Main focus on organising ISASI 2024
- FocusOn... Behind the Flight Deck Door, 29 May 2024
- Increase in number of individual members affiliated with ESASI
- New corporate members affiliated with ESASI: Aer Lingus, Turkish Airlines
- Improving how we communicate
- Release of 2 Newsletters (including a summary of the ESASI 2023 proceedings)
- Support to Military Air Safety Investigators (MASI) group

#### ESASI Financial Update – Matt Greaves (Treasurer)

Matt reported on the final accounting for the in-person 2023 Bratislava seminar and for the ISASI 2024 prepayments.

At the end of 2023, this left ESASI with £8,583 on hand. The Lisbon Seminar should generate a profit to support future ESASI seminars

#### ISASI Update – Rob Carter (ISASI VP & Membership chair)

Rob provided an update on ISASI He stared with the past, present and future ISASI Seminars:

2022 – Brisbane, Queensland – hybrid

2023 - Nashville, Tennessee

2024 – Lisbon, Portugal (with ESASI)

2025 – Denver, Colorado – Renaissance Marriott, Denver

2026 – Dubai, UAE -

The 2025 ISASI Seminar will be held in Denver, Colorado (instead of Cambridge near Boston, Mass). It will be directly organized by ISASI (no profit sharing).

According to Eric Prince, the recent ISASI treasurer, ISASI membership & finances are 'both recovering from Covid'. Rob also reported on the membership management system, which needs to be further improved (at the level of a software called Wild Apricot). The ISASI Council Meeting (ICM) also reviewed changes in membership dues and outcomes.

Rob added that ESASI is well represented within ISASI:

#### ESASI membership – Olivier Ferrante (ESASI Secretary)

On Membership, Olivier reported that there are currently some 203 ESASI Members (i.e. ISASI Members within Europe) and some 32 ESASI Corporate Members, which include State Investigation Authorities, Airlines, Manufacturers, MROs, Universities and Suppliers. It represents an increase of 18% compared to the previous year.

He also pointed out that two airlines joined ESASI since AGM2023: Aer Lingus and Turkish Airlines. New ESASI members are invited to send a short introduction for the ESASI NewsLetter.

The renewal process of ISASI/ESASI members should be enhanced in the upcoming months.

#### ESASI events and projects – Kate Fitzgerald and Paula Dugdale

Kate and Paula spoke about the 'FocusOn...' on-line webinars, delivered by ZOOM, courtesy of the Iceland SIA. These are two-hour virtual meetings with a strong international participation. Since the 2023 AGM, ESASI organized two webinars: on 15 November 2023 'FocusOn...Communicating with Families' and on 29 May 2024 'FocusOn...Behind the Flight Deck Door'. The first one dealt with victims and their relatives about informing them on the safety investigation process and progress. The latest one covered a wide range of topics related to cabin safety.

The next FocusOn... should be on the investigation of Safety Management Systems. It should be held in early 2025.

Arben also informed the AGM about the new website for ESASI, being under development by a small ESASI team.

#### Information Elections – Olivier Ferrante

Olivier reminded the AGM of the ESASI Constitution of January 2021, when ESASI became a registered Charitable Incorporated Organisation (CIO). This Constitution was endorsed unanimously at the first AGM, in July 2021. The first elections were held in November 2021, on-line, resulting (January 2022) in enlargement of the ESASI Committee ('Charity Trustees') from 6 to 10 members.

'Every two years, one-third of the charity Trustees shall retire from office or stand for re-election' so in November 2023 there were on-line elections for three Committee members ('Charity Trustees'), with two existing members standing for re-election (Steve Hull previously left).

There were three candidates for three positions, so Paula Dugdale joined the ESASI Committee in January 2024.

The next elections will be held in November 2025.

#### Q&A and Conclusions – Nuno Aghdassi

Nuno then invited Questions and Suggestions. He mentioned that the next ESASI newsletter will notably contain a summary of ISASI 2024. He closed the meeting saying that the next in-person meeting of the ESASI AGM will be at the ESASI 2025 Seminar in Vienna, Austria. Looking to ESASI 2025, Nuno showed a map of the locations of previous ESASI meetings, welcoming suggestions for the 2026 seminar. He then invited participants to fill in the Feedback forms, which are always helpful.
